SPONSOR

You and your family have access to cover at low, low prices because you, as the family's sponsor, go for medical tests and take out a Death Benefit or a Final Expenses Benefit.

The Final Expenses Benefit offers you cover of between **R50 000** and **R100 000** and the Death Benefit anything from **R100 000** upwards.

PARTNER

Your partner is the person in a permanent marriage-like relationship to you. One partner can be covered for between **R5 000** and **R30 000** by answering medical questions.

To be eligible to take out this cover, your partner must be between 14 and 74 years old.

CHILDREN

Your children can be covered too! Cover of between **R5 000** and **R30 000** is available per child, for all of your biological or legally adopted children, as well as for two children who are living with and dependent on you. You will have to answer medical questions about them.

To take out these benefits, your children must be younger than 17 years old. Their cover will be in place until they are 24 years old. At this point, they can choose to take out further cover with no medical tests.

EXTENDED FAMILY

You can cover your extended family members - with no medical tests required from them at all! Cover of between **R5 000** and **R15 000** is available per person.

These family members must be between the ages of 14 and 74 years to take out this cover.

For the first year of cover, only claims on accidental deaths will be considered. Thereafter any type of death claim will be considered.
